He has participated in the drafting of the Bill of Rights in the final Constitution, various labour statutes including the Labour Relations Act, 1995, and most recently the Minimum Wage Act, amendments to the LRA, Codes of Good Practice: Collective Bargaining, Industrial Action and Picketing and the Accord on Collective Bargaining & Industrial Action. He is the author and editor of various leading books and journal articles on labour law and constitutional law. He has also been an acting judge in the High Court and the Labour Court and is an experienced arbitrator. Halton is the only South African to be appointed to the ILO Committee of Experts on the Application of Conventions and Recommendations (CEAC International Labour Organisation, Geneva).
